## TRAFFIC SAFETY UPDATES

**Public Safety Meeting for Jamaicaaway, Arborway, and Centre Street** Rep. Jeffrey Sánchez hosts another public safety meeting with DCR, State Police and Boston Police on **February 4** from 6 pm to 8 pm at Curtis Hall, 20 South Street. (Parking is limited, so consider carpooling.) To make time for everyone's concerns, please submit comments and suggestions for Rep. **Avon-Pond Intersection** Neighbors have complained to the JHA that visibility at the Avon and Pond intersection is limited by the Armenian Nursing Home's fence at this corner. The JHA readily agreed and contacted the Armenian Home to address the problem. We gratefully acknowledge how promptly the Home had trees and shrubs cut back; however, the position of the fence itself limits drivers' view of Pond Street. We've asked the Home to consider repositioning the fence to increase the sight distance. We look forward to cooperating with the Armenian Home to improve this hazardous intersection.

**Faulkner Employee Parking** Board members **John Lovett, Pat Newman, and Dottie Farrell** are working with Faulkner officials to resolve the problem of employees' parking on Moss Hill streets near the hospital. We can assure you that Faulkner's president, David Trull, is directly dealing with Faulkner employees who are repeat offenders. Of course, our work is not over until conditions for residents on Whitcomb, Lila, and Westchester are definitively improved; we will keep you informed our progress as we continue to work with Faulkner Hospital.

**Centre Street Snow Clearing** According to an agreement between the Department of Conservation and Recreation and the Mass Highway Department, MHD plows Centre Street and DCR clears snow from Centre Street sidewalks. Note that clearing Centre Street sidewalks is a Level 3 priority, which means that machines might not arrive for 12 hours. During that time, DCR still expects property owners to comply with the City's snow clearing policy. However, the JHA has asked DCR to improve their response time during severe snowstorms when sidewalks get re-covered with snow from plows faster than property owners can keep up with. During our last storm, residents gratefully reported an improvement on most (though not all) Centre Street sidewalks.

**Speeding on Pond Street** Boston Police have been seen pulling over speeders on Pond Street. A big thank you to Officer Michael Santry and the BPD for working with the community to improve traffic safety. Neighbors: Remember to reduce your speed on side streets, as well.

## ZONING NEWS

**Showa Dormitory Porch Project** At the December 12 JHA meeting, Showa presented its proposal to enclose ten dormitory porches, the first amendment to its Master Plan. Construction plans in 2008 are intended to enclose just three of these porches. The additional thirty beds replace those in Wing 1, which Showa turned over to its tenant, the British School, for junior and seniors boarding during the week. The project will not be visible to abutters nor will it affect traffic on Pond: BSB boarders are not permitted to use cars during their stay. The JHA recommended to the BRA not to oppose the project under the condition that Showa and BSB conduct a Traffic Access Study to consider ways to mitigate congestion at the entrance of the campus. The JHA appreciates Showa's and BSB's willingness to work our neighborhood to improve traffic conditions.

## Relay for Life

The American Cancer Society's Relay for Life™ is a 24-hour event designed to celebrate those who have survived cancer, remember those who have lost their struggle, and support the fight against this disease. The Relay for Life is a 24-hour walk/jog/run team-based baton-passing relay to raise funds for Cancer Research. As one volunteer put it, the significance of the 24-hour event highlights the reality that cancer never sleeps. The event also encourages us not to stop fighting back. • **Parkside Drive Group Home** Since last November, Vinfen, a care provider for developmentally challenged individuals, has leased 12 Parkside Drive for use as a group home. Rep. Jeffrey Sánchez and the JHA have arranged for residents to meet with representatives from Vinfen and the Massachusetts Department of Mental Retardation on **February 27** at 7 pm at Springhouse, 44 Allandale Road, to learn more about the group home and our new neighbors.

• **Dexter School** Dexter in Brookline is reapplying for a permit, which had expired, to construct a fifth floor on its mid-rise building. The proposed project exceeds the maximum height allowed (35 feet) and therefore requires a special permit. The existing fourth floor and, if approved, new fifth floor would make the building 57.5 feet high. The JHA Zoning Committee recommends to Brookline's Board of Appeal not to oppose the project only under the condition that the school work with the JHA and residents to reduce congestion generated by its commuters and to deal with bus drivers who exceed speed limits.

• **Larz Anderson Park** Brookline Parks and Recreation has scheduled a public meeting **February 11** at 350 Washington Street at 5:30 pm to consider converting Avon-Pond open space to a soccer field and to use Avon Street for service trucks entering the Park. Because of safety issues the JHA recommended to oppose the proposals. See **Zoning Notices** on the JHA website for background information and *JP Gazette* articles.
